4 unconditionally indemnify and hold harmless the SAPS and Afiswitch and all their directors, officers, members and employees as well as the government of South Africa against any liability that results or may result from giving the information or relying on any of the information in this regard, apart from where such liability is a result of the gross negligence of the SAPS or Afiswitch;

5 understand that it is a condition of the SAPS that:  
a the information is given solely for the purpose of my proposed employment or continuation of my employment with you; and  
b the information given to you or Afiswitch will be disclosed to me for comments before a decision is made on my employment or continuation of my employment with you;

6 authorise you and Afiswitch to forward the information to verification information suppliers



acting on your behalf and where necessary send or transfer the information to foreign countries, by electronic or other means, to verify the information. Afiswitch and Nedbank's verification information suppliers will always maintain the confidentiality of the information and use the information for the agreed purpose only;

- 7 understand and accept that the nature of my employment with you requires trust and honesty and consequently I may directly or indirectly handle your cash or finance, and that of your clients. I give consent to Afiswitch to give such information to third parties but only for the purposes of undertaking any background verification checks that the third party may wish to run against my person for purposes of any job application that I might have applied for in that third party and/or in connection with any job that I am currently doing for that third party; and
- 10 unconditionally give up any and all claims of whatever nature and on whatever basis, which I may have against you, which result or may result from giving the information, unless if such claims are as a result of your negligence.
